This Agreement is executed on 30th of March, 2022 between Principal, Government Degree College D.H. Pora, an Institute of Higher Education in district Kulgam and District Librarian, Department of culture with its registered office at District library Anantnag & block library at D H Pora for a period of three years.

### 1. PURPOSE

This Memorandum of Understanding (MOU) establishes a symbiotic relationship between Department of Library, GDC D.H. Pora and the Library of District Anantnag, Department of Culture. Under this MOU, GDC D.H. Pora and Department of Culture will establish resource sharing mechanism for inter library loan service & circulation of available educational resources among registered members of GDC D H Pora & Block Library D H Pora.

### 1. OBJECTIVES OF THE MOU

The objective of this Memorandum of Understanding is :

- a. To promote Resource sharing between GDC D.H. Pora & Block Library D. H. Pora.
- b. To provide a platform of educational exchange & knowledge.

### 2. PROPOSED MODES OF COLLABORATION

GDC D.H. Pora and the Department of Culture propose to collaborate through

- a. Educational resource sharing among students of GDC D.H. Pora and members of Block library D H. Pora

b. Any other appropriate mode of interaction agreed upon between GDC D.H. Pora and Block library D H. Pora .

#### 4. GENERAL CONDITIONS

- a. This MOU, unless extended by the parties' mutual written agreement, may be amended or terminated earlier by mutual written agreement of the parties at any time . Either party shall have the right to unilaterally terminate this MOU upon 60 days' prior written notice to the other party . However, no such early termination of this MOU, whether mutual or unilateral, shall affect the participants' obligations under any Agreement or any other agreement entered into pursuant to this MOU .
- b. Each party will establish a single point of contact which will be Principal, GDC D. H. Pora & District Librarian, Anantnag & will serve as a common interface for their respective organization.

#### 5. RELATIONSHIP

Nothing in this MOU shall be constrained to make either party a partner, an agent, or legal representative of the other for any purpose .

#### 6. ASSIGNMENT

It is understood by the Parties herein this MOU is based on the available resources and expertise of each party . Hence, neither Party shall transfer or assign this Agreement or rights or obligations arising hereunder, wholly or in part, to any third party .



Pora) situated at Bongam Damhal Hanji Pora, an Institute of Higher Education in district Kulgam and Department of Sericulture (hereinafter called DOS) with its registered district office at Mini Secretariat Kulgam and Zonal Office at DH Pora.

### **1. PURPOSE**

This Memorandum of Understanding (MOU) establishes a cooperative relationship between GDC D.H. Pora and the DOS. Under this MOU, GDC D.H. Pora and DOS will establish mutually beneficial links for technology, and research-oriented training for startup of enterprises in the area of Sericulture, cocoon development, and other related areas, to enhance skill enhancement and entrepreneurship development.

### **2. OBJECTIVES OF THE MOU**

The objective of this Memorandum of Understanding is:

- a. To promote interaction between GDC D.H. Pora and the DOS in mutually beneficial areas.
- b. To provide a formal basis for initiating interaction between GDC D.H. Pora and the DOS.

### **3. PROPOSED MODES OF COLLABORATION**

- b. Sponsoring R&D projects, which may be carried out wholly at GDC D.H. Pora or, at the premises of DOS or partly at GDC D.H. Pora and partly at the DOS.
- c. Training of students in areas of interest to the DOS.
- d. GDC D.H. Pora Shall reserve a portion of land for the development of Mulberry plantation at the hands of DOS
- e. Any other appropriate mode of interaction/ student exchange agreed upon between GDC D.H. Pora and DOS.

- a. This MOU, unless extended by the parties' mutual written agreement, may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days' prior written notice to the other party. However, no such early termination of this MOU, whether mutual or unilateral, shall affect the participants' obligations under any Agreement or any other agreement entered into pursuant to this MOU. Moreover, no party shall effect the removing of Mulberry wealth established/to be established on its own, but as per the provisions of State/UT Mulberry act.
